NOTICE IS HEREBY GIVEN that the Town of Yucca Valley, County of San Bernardino, California, will conduct a sale by online auction of Town surplus vehicles. Prospective purchasers may inspect the surplus property to be sold and participate in the online auction at the above referenced date(s) and web site.

Sale of Town surplus vehicles are subject to the following conditions:

All property, including motor vehicles, will be sold "as is, where is" and the Town of Yucca Valley makes no express or implied warranty of any kind including the condition of the property or its fitness for purchaser's intended use.

Purchasers of motor vehicles must complete a Notice of Release of Liability at the time of payment. Motor vehicles may not be operable and may not have a State of California Smog Certificate. The Town will provide purchaser an executed release of interest in the motor vehicle.

Payment shall be in the form of cash or credit card payable to the Town of Yucca Valley in US dollars.

The successful bidder must make full payment and remove the property prior to 3:00PM, Monday, September 19, 2016, five (5) days after the close of the auction, unless other arrangements are made with the Town.

Bidders must be at least 18 years of age, and no pre-auction bids are permitted prior to Thursday, August 25, 2016.
