CONTINUANCE OF TIME FORMS AND INFORMATION

This application should be submitted to request a continuance or extension of a review deadline.

INFORMATION

A continuance of time can be requested by an applicant to extend a review deadline. These are often requested by an applicant and the County to resolve and clarify issues surrounding a proposed development project. State law allows the Office of Planning to:

1. Have up to thirty (30) days to accept or reject your "Development Project" application after it has been filed;
2. Have up to fifty (50) days beyond the acceptance date to take an action on those development project applications subject to the provisions of the State Subdivision Map Act (i.e. Tentative Tracts, Tentative Parcel Maps, Minor Subdivisions, etc.);
3. Have up to six (6) months beyond the acceptance date to take an action on all other development projects; and
4. Have up to one (1) year to take an action on any development project which is required to prepare an Environmental Impact Report.

Note: Development projects do not include General Plan Amendments, Land Use District Changes or Agricultural Preserve / Land Conservation Contract actions that are not associated with other Development Project applications.

State law allows applicants and the Town to mutually agree to continuances of the above time limits, not to exceed the following:

1. Projects subject to the Subdivision Map Act may be continued to either six (6) months or one (1) year as specified in items 3 and 4 above; and
2. All development projects including projects subject to the Subdivision Map Act may be continued an additional ninety (90) days beyond the applicable six (6) month or one (1) year deadlines.
