### **Background and Analysis:**

Youth Commissioners of the 2009-2010 term voiced concerns over drug use and underage drinking within the local teen community. Commissioners made a presentation to Yucca Valley Town Council during the May 4, 2010 meeting which included a recommendation to establish a Social Host Ordinance. The Town Council indicated support for the concept and directed staff to investigate the subject. The 2010-2011 Youth Commission approved a work plan which proposes to continue the work of the previous Youth Commission with the preparation of a formal recommendation to the Parks, Recreation and Cultural Commission and Town Council regarding the establishment of these regulations.

Dan Skiles, Institute for Public Strategies, along with representatives of the Ready, Aim, Fire Coalition attended the December 6, 2010 Youth Commission meeting to make a presentation on the Social Host Ordinance. A sub-committee of the Youth Commission was formed to work with Town Staff to draft a local Social Host Ordinance for presentation to the public at the Parks, Recreation and Cultural Commission February 8, 2010 meeting. Members of the sub-committee include Commissioners Goddard, Blevins, Woolling, Hyso, and Felix. The sub-committee will meet for a Youth Commission workshop on January 17, 2011 to prepare a recommendation based on the review of existing Social Host Ordinances conducted in November 2010. The members will schedule a meeting with the Town's management team to discuss the work to date on the Social Host Ordinance recommendation and request that the introduction of the Social Host Ordinance be scheduled on the Town Council's March 15, 2010 agenda.

### Background and Analysis:

Several members of the 2009-2010 Youth Commission expressed concern about the safety of local parks, primarily because of the behavior of some younger park patrons. It was noted at the time that, in the opinion of some youth commissioners, the parks had become a location for the buying/selling of drugs as well as other anti-social activities. The conclusion was expressed that such activity had a negative impact on the ability of families and others to enjoy local parks.

The discussions of possible solutions for the perceived problem included investigation of the smoke-free parks ordinances that have been adopted in other California cities. While smoking is a common denominator in much of the objectionable teen behavior at parks, it has also been a concern at other park activities, such as summer concerts, sports activities, and playground use.

Staff will initiate discussion with the Youth Commission about smoke-free parks. The benefits and anticipated problems will be discussed as well as process for enacting a local ordinance. With consensus among both commissions as to the advisability of pursuing this measure, staff will frame up the steps and return to both commissions for periodic input and status reports.
