#### 8. Proposed Rules for the Use of Dog Park- Discussion only

Director Schooler reported on the Southside Park development. The construction is underway and is anticipated to be completed late summer. The first phase includes playground, parking lot, restrooms, picnic shelter and Yucca Valley's first dog park. Staff has researched the operation of dog parks in other areas and compiled a draft set of rules.

Director Schooler led a review of each proposed rule, noted Commissioner input, and will return with a final draft in July. The Commissioners concurred with most of the rules, but asked for further study or clarification in some areas:

3. No more than two dogs per owner/handler.

Question: what about dog handles/sitter who may have more than two dogs they are watching?

5. All dogs must be altered prior to using the park (dogs in heat are not permitted). Question what about puppies, or breeders.

10. Do we want to limit the number of dogs permitted inside each area of the dog park at one time

Answer: Not at this time

12. Dog collars: no choke, prong, pinch or spiked collars are permitted. Question: What about dogs in training?

13. Children under 12 are not permitted in the dog park.

Question: Does that mean without adult supervision or not at all?

27. Failure to comply with dog park rules could result in a citation and /or fine Add: Expulsion from the park.

**Prior Commission Review:** At the regular Commission meeting on June 12, 2012, the Commissioners reviewed a draft of dog park rules and provided input to staff.

**Discussion:** The construction of Phase 1-a of the Southside Park, which includes the community's first dog park, is underway and is anticipated to be completed in late summer. Although temporary off-leash times have been granted at Machris Park for several months, the Town has no experience with dog parks or with the rules regulating the use of these facilities.

Staff has investigated the dog park rules used in other communities and compiled a draft list of rules for local consideration. The PRC Commission reviewed the draft list at their June meeting and provided comments to staff. As a result, the proposed list of dog park rules has been modified to reflect Commissioner input, and to attempt to ask and answer related questions.

The Commission is requested to review and discuss the revised list and finalize a recommendation to the Town Council.

#### Proposed Dog Park Rules draft – updated 7/5/12

- 1. Hours: Sunrise to dusk.
- 2. Dogs must be leashed when entering or exiting the dog park. (Moved to #2)
- 3. No animals other than dogs are permitted.
- 4. No more than two *(three? four? no limit? What about dog sitters?)* dogs per owner/handler. Animal Control Staff input: The reason for this suggestion is if the dogs become unruly, it can be difficult for one person to handle more than two dogs.
- 5. Dogs must be at least 4 months old, licensed and current on vaccinations. Proof must be provided upon the request of Yucca Valley Animal Control staff.
- 6. All dogs must be altered prior to using the park. (Good rule? What about puppies?

  Breeders?) Dogs in heat are not permitted. Animal Control Staff input: Great Rule!!
  Rule #5 says dogs must be over 4 months so that eliminates puppies. I would keep this rule because there are many breeders of Pit Bulls in our area and we do not want unaltered pit bulls. Plus, it complicates the process because then they would have to prove they are "breeders". And finally, testosterone is the main contributor to aggression.
- 7. Aggressive, unmanageable and/or unruly dogs are not permitted. Dogs must be leashed and removed at the first sign of aggression, mounting, hostile or combative behavior towards people or other animals.
- 8. Sick dogs, dogs with communicable diseases (i.e.; mange) or injured dogs are not permitted.
- 9. Small dog area no dogs over 25 pounds (good place to draw the line?) allowed inside of the small dog park. Animal Control Staff input: I feel this is a good place to draw the line.
- 10. Dog collars: no choke, prong, pinch or spiked collars are permitted (good rule? What about for training? <u>Animal Control Staff input</u>: Good rule. This is an off-leash area so if they want to use them for training, they can use them off of the dog park site. These type of collars may injure a dog, whether it is the dog wearing the collar or another dog, when they are running around loose together.
- 11. Children under 12 are not permitted in the dog park. (good rule? Good place to draw the line? If not, what age? Parental supervision?) Animal Control Staff input: Good safety rule. I can see no reason why people should bring young children into a dog park play area. It can get way out of hand. While some children may be okay at a younger age, there is no way we can pick and choose who gets to go in and who doesn't. Also, children are the number one victim of dog bites. Plus, children can get pounced on, hurt, knocked over by the larger dogs especially because of their energy.

- 12. No strollers, carriages, children's toys, scooters, skateboards, bicycles, etc.
- 13. Off-leash dogs must remain inside the fenced area and be accompanied by, and under voice control of, their owners/handlers at all times
- 14. Owners/handlers must keep a leash on their person at all times
- 15. Owners/handlers may not leave their dogs unattended inside of the park
- 16. Owners/handlers are responsible for injuries or damage caused by their dog
- 17. Owners/handlers are to extend courtesy to other dog park users. This includes keeping dogs from jumping at or annoying others
- 18. Dogs barking excessively must be quieted or removed.
- 19. No smoking, alcoholic beverages, food (animal or people) or dog treats are permitted.
- 20. No activities unrelated to dogs is allowed (i.e.; kite flying).
- 21. Except when entering and exiting, gates must be kept closed at all times.
- 22. Owners/handlers are to clean up after their dogs. Please deposit dog feces in plastic bags. Seal the bag before depositing in the trash receptacles.
- 23. The dog park is subject to periodic closure without notice for maintenance.
- 24. Dog obedience classes or events other than those authorized by the Town of Yucca Valley are prohibited.
- 25. Failure to comply with dog park rules could result in a citation and/or fine (and/or suspension/expulsion from the park? Enforcement problem?) Animal Control Staff input: Finding the time to enforce anything seems to be a challenge these days! Suspension may also be difficult because who is to stop them when they go in?

#### Removed:

- Question about limiting the number of dogs at any given time. Animal Control Staff input: We can wait and see.
- Question about limiting the large dog area to large dogs. Animal Control Staff input: If someone has a large dog and a small dog, I feel it is their choice if they want to go into the large dog park. However, it is not their choice to go into the small dog park with a larger dog. More than likely, the senior people will have small dogs so the small dog portion will be much safer for them too.
