Prior Commission Review: None.

Recommendation: Move to approve the deaccession and sale of the identified list of taxidermy marsh bird specimens and designate the proceeds to be used for collections care and acquisitions.

Summary: The Hi-Desert Nature Museum's Collection Policy provides for the deaccessioning of objects that no longer fulfill the museum's mission. The taxidermy marsh birds previously on display in the Diorama Room are not relevant to the museum's exhibits and programs and have been identified as appropriate for deaccession. The Sonny Bono Salton Sea National Wildlife Refuge Complex has offered to accession the birds and utilize them in exhibits for educational interpretation.

Discussion: The Hi Desert Nature Museum's Collection Policy provides for the deaccessioning of objects that no longer fulfill the museum's mission. In 2007, the museum completed a renovation plan for the permanent exhibitions which included the removal of taxidermy specimens not native to the local desert environment and updating the dioramas with desert animals, since then the marsh birds were boxed up in the collections room. The marsh birds have been identified as unrelated to the museum's mission and staff recommends the deaccession of these taxidermy specimens from the permanent collections.

The collection policy provides for disposition of deaccessioned objects through various means. Since museums maintain their collections as a public trust, the preferred method of deaccession is through donation or sale to a non-profit, educational organization. Chris Schoneman, with the Sonny Bono Salton Sea National Wildlife Refuge agreed to accession the taxidermy specimens and to display them properly. The marsh birds are native to the Salton Sea area and can be used in support of their mission for educational programs.

The American Association of Museums has established museum ethics for the deaccession of collections. Their code of ethics states that proceeds from the sale of collections are to be used consistent with the established standards of the museum's discipline, but in no event shall they be used for anything other than acquisition or direct care of collections. Therefore, the \$100 received from the sale of the marsh birds to the Sonny Bono Salton Sea National Wildlife Refuge Complex will be designated in a special museum account to be used for collections care and acquisitions.





The 2014-2015 Youth Commission's term was from November 2014 to June 2015. The main focus of the term was to provide community service through volunteer opportunities and to raise awareness of bullying in our local schools. Highlights of the term include:

YOUTH OUTREACH

The Youth Commission performed an anonymous survey of over 250 local high school and middle school students on their experience with bullying. The results are listed below and have been incorporated in outreach materials that will be distributed at Youth Commission forums and events along with information about how to report bullying to school officials.

53% of participants reported experiencing direct bullying (pushing, shoving)

60% of participants reported experiencing indirect bullying (rumors, exclusion, mocking)

40% of participants reported experiencing cyber bullying (bullying on social media)

52% of participants reported that they intervened when they saw a friend or student being bullied.

The Youth Commission encouraged students to use the Anonymous Alert system and online reporting forms available through local schools to report bullying incidents.

COMMUNITY SERVICE

Youth Commission members volunteered their time and contributed to the success of many Town events. Hundreds of residents enjoyed these fun activities including:



Discussion: The Town recognizes the economic and quality of life contribution of the Hwy 62 Open Studio Art Tours and has a history of supporting the event. Through 2010, the Town allocated funds for the event through its Community Partnership program. Beginning in 2011, Town support was in the form of in-kind donations including hosting of the Art Tours Collective Show and Reception as well as providing marketing support in the Experience Yucca Valley Town publication and on Town websites, a value in excess of \$2500.00. The Town has provided these services in an alternating fashion with the city of 29 Palms through the present and was the host of the 2014 Art Tours Collective Show last fall.

Financial support beyond the present in-kind commitment would traditionally be provided through application for a Town Community Partnership. The Community Partnership applications for FY 2015-16 have been completed. Partnership applications for FY 2016-17 and FY 2017-18 will be available in December of 2015 with funding for FY 2016-17 partnerships available on July 1, 2016.

Fiscal impact: Funding of the in-kind support of the 2014 Hwy 62 Open Studio Art Tours was included in the FY 2014-15 Community Services budget. Due to the alternating location of the Hwy 62 Art Tours Collective Show, funding for these in-kind services is not included in the FY 2015-16 budget. Funding of ads or sponsorship of the 2015 Hwy 62 Open Studio Art Tours event would require Town Council action to amend the FY 2015-16 General Fund Budget.
