#### STAFF REPORTS

#### 6. REVIEW PUBILC ART POLICY

Director Schooler reported that at the December 2011 meeting he handed each of the commissioners a copy of the current Public Art Policy and invited then to mark it up with questions or suggestions. He gave a brief history of the Public Arts Advisory Committee which has been dissolved and the responsibilities of that group are now the Parks, Recreation and Cultural Commissions. He stated that in this agenda is a copy of a marked up policy, with some suggested changes. He mentioned that prior to the dissolution of the Public Art Advisory Committee there was a review of the policy in order to clarify the process and address art acquisition issues.

Commissioner Jones inquired on changing of title from "Arts Policy" to "Art Policy." Director Schooler agreed that either term is inclusive, but the wording should be consistent. He noted that staff has found that most people refer to the policy as Public Art Policy.

Commissioner Jones shared her comments on the policy.

- Suggested adding a statement to the effect of "Upon acceptance, the Town can remove store relocate, or offer for sale..."
- Suggested amending item D of the Criteria section as follows: "the Town has limited storage space and must consider the cost of processing, insuring, maintaining, displaying, installation or storing artwork"
- Suggested amending item D of the Acquisition Procedures paragraph to read: "Items acquired may be exhibited, preserved, conserved, stored, sold, and used for fundraising or other wise utilized in the best interests of the Town, at the Town's sole discretion."

Chair Evans inquired if the policy addressed art on privately-owned buildings? Director Schooler stated the policy is silent on that issue. He mentioned staff will follow up with the City of Twentynine Palms to see how they deal with their murals.

#### 7. PUBLIC ART LOCATIONS

Director Schooler gave a PowerPoint presentation during the discussion of possible public art locations. Director Schooler talked a briefly on each current piece of public art the Town owns and their locations, along with some slides of locations that might be considered for the placement of public art in the future.

## 8. RECREATION PRESENTATION-SPORTS PROGRAMS

Director Schooler reported on sports programs conducted by the Town's Recreation Division. He displayed powerpoint slides and explained the department's role in providing community sports activities. Director Schooler mentioned some of the challenges for 2012: facility limitations, teen programming, increasing diversity, struggling non-profits, and budget impacts.

#### 9. MEETING CALENDAR

Director Schooler reported that at the last commission meeting there was discussion on staff providing a Town meeting calendar, in which the Parks, Recreation and Cultural Commissioners would look at and discuss which meeting each of them would like to attend. Chair Evans asked the commissioners each look at the calendar and see what they can attend.
