# 5. Youth Commission 2014-15 End of Term Report

Community Services Manager Earnest introduced Aaron Ahmadi, Chair of the 2014-15 Youth Commission. Chair Ahmadi gave a review of accomplishments for this term. He stated one of the more serious issues the Youth Commission tackled included collecting over 250 survey responses from middle and high school students on the issue of bullying. Chair Ahmadi stated that the youth commissioners worked several Town special events including Halloween Spectacular, Tree Lighting Ceremony, Festival of Lights Parade, Family Fun Days at Paradise Park, Healthy Hearts Run and the Annual Easter Egg Hunt.

The Youth Commission is currently preparing for school forums to be held at Joshua Springs Christian and La Contenta Middle School in May. During the forums the commissioners will share the information on the anti-bully message, as well as lead the students in activities and games.

Community Services Manager Earnest stated that Youth Commission Chair Ahmadi did an amazing job this year. Chair Eigner thanked Aaron Ahmadi and the rest of the Youth Commissioners.

# 6. Morongo Basin Cultural Arts Council Presentation

Manager Earnest introduced Mr. Paul Morehead, Marketing Director for the Morongo Basin Cultural Art Council. Mr. Morehead distributed the 2014 Hwy 62 Open Studio Art Tour publication, along with a supplement that featured sponsorship opportunities and marketing data. He stated the organization is a 501c3 and is currently run by volunteers. Commissioners asked additional questions of Mr. Morehead regarding the event.

Mr. Morehead inquired if the Town could support the event by means of financial or inkind assistance.

Chair Eigner encouraged Mr. Morehead to apply for the Towns Community Partnership program when it comes available.
