## 3. Hi Desert Nature Museum 2016-2020 Draft Strategic Plan Revised

Community Services Manger Sue Earnest introduced Museum Supervisor Stefanie Ritter. Ms. Ritter reviewed the incorporated revisions to the document that were suggested at the March 8 meeting.

Commissioner Keesling suggested some additional mentioning of the Yucca Valley artist.

Commissioner Quander inquired about the relationship between the Museum and the Joshua Tree National Park. Ms. Ritter stated yes the Museum does have a relationship with the park, mostly with education.

#### 4. Youth Commission Update

Community Services Manger Sue Earnest reported on the activities of the 2015-16 Youth Commission. Ms. Earnest reported that the commission has been meeting monthly with an additional workshop as needed. Staff is developing a program which will utilize the Youth Commissioners time in a productive way.

Manger Earnest reported that staff is reviewing the meeting schedule of the Youth Commission. The meeting schedule is currently October through June. The meeting in June typically has very low attendance due to the youths involvement in graduation. Staff is looking towards changing the meeting months to October through April.

Staff is exploring the possibility of a six week youth volunteer program during the summer. Discussion was held and input from the Parks, Recreation and Cultural Commission was favorable for a summer youth volunteer program.
