RE: 2016 Community Survey – Summary of the Results

Introduction:

The Town of Yucca Valley commissioned Godbe Research to conduct a telephone survey to assess resident satisfaction and priorities for Town services.

The results show constituents are satisfied with the job the Town of Yucca Valley is doing to provide Town services.


Among other findings, the survey also indicates that respondents are interested in providing local funds to address community needs, including a measure to reduce the cost of funding the sewer system and a measure to maintain town services. There measures are between 6 and 21 points above their respective requirements.

Methodology Overview:

Interviews were conducted from March 30 through April 6, 2016, and the average phone interview time was approximately 25.5 minutes. A total of 305 Town of Yucca Valley respondents participated in the survey, and the study parameters resulted in a margin of error of plus or minus 5.48 percent.

Satisfaction the Town of Yucca Valley's Job Performance:

Sixty-five percent of survey respondents indicated that they are satisfied with the job the Town is doing to provide Town services. This is a satisfaction to dissatisfaction ratio of 2.4 to 1.



Respondents Identified the Following Service Priorities:

Survey respondents were presented with a variety of needs and services to determine their importance. The survey results suggest clear priorities including "Maintain a safe, clean, reliable water supply", "Prevent violent crimes", "Reduce the cost to taxpayers for funding the sewer system by up to 30% per year", "Maintain youth violence prevention and gang intervention programs", and "Support fire protection services", among other important services.

Respondents Agree with Maintaining Public Safety and Maintaining Roads:


Respondents supported statements "The sewer measure is a special purpose measure that requires by law that all measure funds are spent on reducing the costs of the sewer system for residents. Funds from the measure cannot be redirected or taken for other uses by the Town Council", "More and more parolees and sex offenders are being released early because of state cuts to prisons. This measure will improve tracking of parolees and sex offenders to help make our neighborhoods safer", and "The measures require independent taxpayers' oversight committee, mandatory financial audits, and yearly reports to the community to ensure the funds are spent as promised" among the others listed below at the two-thirds level or higher.

The Survey Results Indicated Potential Support for a Measure to Reduce the Cost of Sewer Service and a Measure to Maintain Yucca Valley Services among November 2016 Voters.

After hearing details and a variety of informational statements about a measure to reduce the cost of funding the sewer system, 74% of likely November 2016 voters indicated support. If placed on the ballot, this type of measure requires a two-thirds majority threshold to pass.

Similarly, a measure to make neighborhoods safer was supported by 71% of likely November 2016 voters. If placed on the ballot, this type of measure requires a simple majority threshold to pass.



Conclusions:

The results show constituents are satisfied the job the Town is doing to provide services.

The survey also indicates that respondents support measures to reduce the cost of funding the sewer system and maintain Yucca Valley services at between 6 and 21 points above the respective requirements and establish a clear priority for the use of the funds.
