**AUTHORITY:** In accordance with the Town of Yucca Valley Ordinance No. 138, Section 10.02.110, Public Nuisance Animals, whenever an Animal Control Officer determines there exists probable cause to believe that a animal may be or is a public nuisance and/or has demonstrated behavior to a lesser degree as defined under potentially dangerous dogs, of this chapter, the officer shall conduct an investigation and schedule an administrative hearing to determine whether or not the dog in question shall be declared a public nuisance. Petitions shall be public records and open to public inspection.
