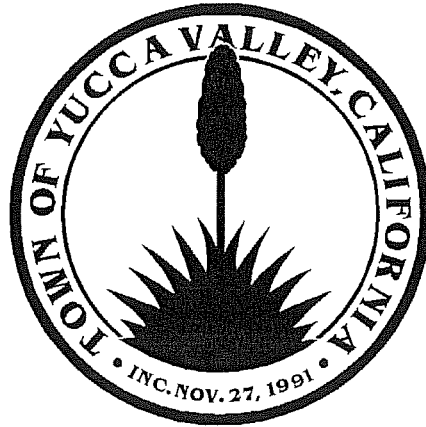

Discussion: The Successor Agency retains approximately \$4.2 million in bond proceeds from the former Yucca Valley Redevelopment Agency. The Successor Agency has the authority to expend the bond proceeds in accordance with the provisions and intent of the original bond documents.

The committee will meet with staff, identify alternative expenditure plan priorities, and return to the Successor Agency with a report and recommendations in the first quarter of 2014, which may coincide with mid-year budget review and the FY 2014-15 budget preparation cycle.

Alternatives: None recommended.


Fiscal impact: Approximately \$4.2 million in bond proceeds remain for allocation and appropriation.
