

3. FY 2011-12 Proposed Budget

A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE TOWN OF YUCCA VALLEY, CALIFORNIA, ADOPTING THE 2011-12 REDEVELOPMENT AGENCY BUDGET AND APPROVING APPROPRIATIONS FOR THE FISCAL YEAR COMMENCING JULY 1, 2011 AND ENDING JUNE 30, 2012

Treasurer Yakimow reported the proposed budget assumes the continued existence of redevelopment at the state level. With the various alternatives and proposals under consideration in the state capital as part of the current year budget, there is a distinct possibility that the redevelopment landscape in 2011-12 will look and function much differently than today. Funding for two new programs area included in the proposed 2011-12

Agency budget. The first is funding in the amount of \$21,500 to support the economic development activities of the Chamber of Commerce within the project area, and an allocation of \$23,500 in funding is identified for the Desert Regional Tourism Agency for their travel and tourism programing and economic development related activities.

Chair Huntington opened the public hearing,

Margo Sturges, Yucca Valley, questioned when the maintenance responsibility changed to the Town for the units Unity Home is using.

There being no one else wishing to speak, Chair Huntington closed the public hearing.

Treasurer Yakimow commented, with respect to Unity Home, they do lease agency property and there is some basic maintenance we are responsible for.

Agency Member Rowe questioned if funding to nonprofits will be revisited based on the changes to RDA. Treasurer Yakimow advised that if RDA law changes and that funding can't occur, staff will bring the issue back for consideration.

Chair Huntington asked if these two funds will meet the criteria since RDA is going to go under increased scrutiny. Treasurer Yakimow commented that it is common in other agencies and does meet the criteria. Chair Huntington questioned if the Chamber agreement is essentially the same as last year. Treasurer Yakimow advised there is no significant change in scope.

Council Member Abel questioned the decreased funding over the last few years. Treasurer Yakimow advised, in terms of funding that comes in, the Agency is primarily funded from tax increment, since the assessed values have gone down the amount of money coming to the Agency has gone down about 10%. Council Member Abel questioned what would happen if we if do not get the affordable senior housing project going. Treasurer Yakimow advised that those moneys would remain in the Low Mod fund if the grant funding does not come in.

Agency Member Abel moved to adopt Resolution No. RDA-11-06, approving the Fiscal Year 2011-12 Budget, and designating those officials authorized to make requisitions for encumbrances against appropriations; Approve the draft agreement between the Town of Yucca Valley and the Yucca Valley Chamber of Commerce, and authorize the Executive Director and Agency Attorney to make any non-substantive changes. Agency Member Rowe seconded. Motion carried 4-0 on a roll call vote.

4. FY 2010-11 Budget Amendments

A RESOLUTION OF THE REDEVELOPMENT AGENCY, OF THE TOWN OF YUCCA VALLEY, CALIFORNIA, AMENDING THE 2010-11 REDEVELOPMENT AGENCY BUDGET

Treasurer Yakimow advised this item consists of clean up amendments related to current year activity, and includes transferring \$400,000 from the senior housing project general account to the senior housing project CORE Account, appropriating \$450,000 of undesignated reserves of the debt service fund to assist in funding the General Plan update and appropriating \$100,000 of undesignated reserve of the housing fund to assist in funding of the General Plan update.

Town Manager Nuaimi advised the amendment of the \$400,000 to the Senior housing project CORE account is included in the total project costs and is a part of the gap financing.

Margo Sturges, Yucca Valley, commented regarding the additional amount for the CORE account and questioned the additional \$50,000 from RDA for the general plan update.

Treasurer Yakimow advised the 50/50 split is between the debt service account and the Town's general fund, the additional \$100,000 to address some of the housing considerations as required by the state.

Agency Member Hagerman moved to adopt Resolution No. RDA-11-07, amending the fiscal year 2010-11 Adopted Budget by transferring \$400,000 from the Sr. Housing Project general account to the Sr. Housing Project – CORE Account; appropriating \$450,000 of Undesignated Reserves of the Debt Service fund to assist in the funding of the General Plan Update; and appropriating \$100,000 of Undesignated Reserves for the Housing Fund to assist in the funding of the General Plan Update. Agency Member Rowe seconded. Motion carried 4-0 on a roll call vote.

Administrative Services Director Yakimow advised that, as part of the language of AB 1X26, on or before August 27, 2011, and in response to the court action to date in review of the legislation, the Agency Board must adopt an Enforceable Obligation Schedule listing all obligations of the Agency that are enforceable. The schedule must be adopted at a public meeting of the Agency, posted on the Town's website and transmitted to the San Bernardino County Auditor Controller, the State Controller and the Department of Finance. Due to the uncertainty resulting from the latest Court Action regarding AB 26 & 27, the resolution is written in such a way that provides the most flexibility for the Town in terms of addressing the possibility of certain portions of the legislation being upheld or struck down.

Agency Member Hagerman moved, pursuant to Assembly Bill 1X26, to adopt Resolution No. RDA-11-08, establishing the Agency's Enforceable Obligation Schedule. Agency Member Rowe seconded. Motion carried 5-0 on a roll call vote.

Discussion:

The State of California adopted its fiscal year 2011-2012 budget with several provisions that required funds from local governments. In a maneuver to balance the State budget, the State Legislature abolished redevelopment agencies with the passage of Assembly Bill X1 26 (AB 26) so as to keep the tax increment money currently allocated to redevelopment agencies. However, the Legislature concurrently passed companion legislation, Assembly Bill X1 27 (AB 27), which provided that redevelopment agencies could continue if they chose to pay the State of California a "voluntary remittance". On

July 28th, the Town and the Agency took actions to opt-in under AB 27, under protest. The opt-in presumably eliminated the need for the Agency to adopt the Preliminary Draft Recognized Obligation Payment Schedule (PDROPS) as this was required under AB 26 for those agencies that chose not to opt-in but instead, dissolve. However, the following subsequent actions have necessitated the adoption of this schedule.

In July 2011, the California Redevelopment Association and the California League of Cities filed a lawsuit contesting the validity of AB 26 and AB 27 with the California Supreme Court. On August 11, 2011, the Court issued a stay on the enactment of the majority of AB 26 and 27. The stay was subsequently modified by another order from the Court on August 17, 2011. In leaving a small portion of AB 26 in place, the Court created a situation forcing the Agency to take certain actions, irrespective of the Agency's decision to opt-in or opt-out.

To address the first of those actions, the Agency adopted the Enforceable Obligation Payment Schedule (EOPS) reflecting projected obligations through the end of December 2011. This action was completed by the Agency at the meeting of August 16⁻ 2011. A second action is now required approving a Preliminary Draft Recognized Obligation Payment Schedule (PDROPS) for the first six months of 2012. The PDROPS allows the Agency to make payments, other than for bonded indebtedness, that would otherwise be prohibited even though the Agency opted-in.

In light of the forgoing, the PDROPS is included as part of this staff report, along with the requisite resolution adopting the schedule. Due to the legal uncertainty resulting from the latest Court action regarding AB 26 & 27, the resolution is written in such a way that provides the most flexibility for the Town in terms of addressing the possibility of certain portions of the legislation being upheld or struck down, as the case may be.

Staff recommends approval of the resolution in order to be able to make the necessary payments for various obligations and to authorize the Executive Director or Treasurer of the Agency to sign all paperwork and to take all necessary actions to forward the documents to the State and County.

Financial Impact: Approval of the resolution allows the Agency to make payments for its various obligations using Agency funding for the fiscal year. Failure to approve means the Agency will be unable to make any payments other than for bonded indebtedness.

WHEREAS, Health and Safety Code Section 34169(h) ("Section 34169(h)") provides that the Agency shall prepare a preliminary draft of its initial recognized obligation payment schedule (PDROPS) by September 30, 2011.

WHEREAS, Without waiving its rights under the Modified Stay, or any of its objections that certain or all of the provisions of AB 26 and AB 27 violate the State Constitution and other laws and are invalid and unenforceable, the Agency desires to approve the PDROPS attached hereto and incorporated by reference.

WHEREAS, All other legal prerequisites to the adoption of this Resolution have occurred.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS by the Yucca Valley Redevelopment Agency that:

Section 1. The Agency hereby finds and determines that the foregoing recitals are true and correct.

Section 2. The PDROPS attached hereto and incorporated by reference and attached as Exhibit A herein is hereby approved.

Section 3. Agency Executive Director or Treasurer, is hereby authorized to take such actions as are necessary and appropriate to comply with Section 34167(i) and the Modified Stay.

Section 4. This Resolution shall take effect immediately upon its adoption.

Section 5. Agency Executive Director or Treasurer shall transmit the PDROPS to the Town of Yucca Valley, as the Town shall be the Agency's successor.

Under AB 27, the Town is authorized to enter into an agreement (the "Remittance Agreement") with the Agency pursuant to which the Agency will agree to remit tax increment funds available to the Agency to make the annual remittance payments to the County. All amounts committed to the Town by the Agency in such agreement are assigned to the State in the event the Town does not remit the required payments to the County.

Additionally, for the 2011-12 Fiscal Year only, the Agency is also authorized to suspend its deposit into the Low- and Moderate-Income Housing fund, as may be necessary to meet the Agency's debt and other obligations, current priority program needs, or the Agency's obligations under the Remittance Agreement. Staff has determined that the use of this authority is required. The Agency needs to suspend a portion of its deposit into the Low-Mod- Housing Fund in order to assure that sufficient funding is available to finance the Agency's redevelopment programs and activities.

The following table lists the non-housing programs and projects, along with the available funding for FY 2011-12, and demonstrates the anticipated shortfall due to the required payment under AB 27.

Staff has evaluated the fiscal impact of the legislation and has determined that the Agency will be able to make the anticipated payments in order to continue to operate during the current five-year implementation planning period. This would permit the Agency to continue to fund certain capital projects, affordable housing and the administrative budget. However, remittance of the payments will significantly curtail the ability of the Agency to undertake large new projects.

Financial Impact: In future years, if the Agency has insufficient funds to make the remittances required under the Remittance Agreement, then the Town is still required to make the payments from any lawfully available funds, or permit the Agency to dissolve, following the procedures set-forth in AB 26. For FY 2011-12, the shortfall between Agency non-housing revenues (tax increment revenues) and its debt service and its current period priority program needs is estimated to be approximately \$873,160. Legislative authority permits a portion of this shortfall (\$435,000) to be funded out of the current year Housing Set-Aside tax revenues.

REMITTANCE AGREEMENT

THIS REMITTANCE AGREEMENT ("AGREEMENT") is made and entered into on ______, by and between the TOWN OF YUCCA VALLEY (referred to herein as "Town"), and the REDEVLOPMENT AGENCY OF THE TOWN OF YUCCA VALLEY, a public body, corporate and politic ("Agency"), with reference to the following facts:

RECITALS

WHEREAS, Assembly Bills X1 26 ("AB 26") and X1 27 ("AB 27") were passed by the State Legislature on June 15, 2011, and signed by the Governor on June 29, 2011.

WHEREAS, upon enactment, AB 27 codified Part 1.9 of Division 24 of the California Health and Safety Code, commencing with section 34192 ("Part 1.9").

WHEREAS, AB 27 established a "voluntary alternative redevelopment program" whereby the Town may choose to continue the operation of the Agency pursuant to Part 1.9, upon the enactment of an ordinance by the Town to comply with the provisions of Part 1.9 and make certain remittances described in California Health and Safety Code Section 34194 to the San Bernardino County Auditor-Controller ("County Auditor"). All section references in this Agreement are to the California Health and Safety Code, unless otherwise specified.

WHEREAS, the Town Council of the Town of Yucca Valley (the "Town Council") on August 16, 2011, adopted an Ordinance committing the Town to comply with and make the remittances required by Part 1.9 and continue the existence and activities of the Agency after enactment of AB 27 (the "Ordinance").

WHEREAS, pursuant to Section 34194.1, in making remittances to the County Auditor pursuant to Section 34194, the Town may use any available funds not otherwise obligated for other uses.

WHEREAS, pursuant to Section 34194.2, the Town may enter into an agreement with the Agency, whereby the Agency will transfer a portion of its tax increment to the Town, in an amount not to exceed the annual remittance required each year pursuant to Chapter 3 of Part 1.9, for the purpose of financing activities within the redevelopment area that area related to accomplishing the Agency's project goals.

WHEREAS, the purpose of this Agreement is to provide for the transfer of funds pursuant to Section 34194.2 to enable the Town to make the remittances required by Part 1.9.

WHEREAS, the obligations of the Agency under this Agreement shall constitute an indebtedness of the Agency for the purpose of carrying out the redevelopment plan for the Yucca Valley Redevelopment Project Area, as currently constituted or as it may be amended.

WHEREAS, the validity of AB 26 and AB 27 is being challenged in a lawsuit entitled California Redevelopment Association, et al. v. Matosantos, et al., California Supreme Court Case No. S194861 (the "CRA Lawsuit") and other lawsuits challenging the validity of AB 26 and AB 27 may be filed.

WHEREAS, pending a decision on the merits in the CRA Lawsuit, the California Supreme Court has stayed the effectiveness of portions of AB 26 and AB 27, including, but not limited to, Sections 34194, 34194.1 and 34194.2.

WHEREAS, it is the intention of the Town and the Agency for this Agreement to become effective only if and when the stay ordered by the California Supreme Court in the CRA Lawsuit has been lifted or dissolved; provided, however, if the decision on the merits in the CRA Lawsuit or any other lawsuit challenging the validity of AB 26 and/or 27 is that provisions of AB 27 authorizing the making of remittances to the County Auditor are invalid for any reason, this Agreement shall be null and void and of no effect.

NOW, THEREFORE, TOWN and AGENCY mutually agree as follows:

1. **EFFECT OF RECITALS.**

The recitals above are an integral part of this Agreement and set forth the intentions of the Parties and the premises on which the Parties have decided to enter into this Agreement.

2. OBLIGATIONS OF THE PARTIES.

A. For purposes of this Agreement, the term "Net Available Tax Increment" means any tax increment funds allocated to the Agency, net of (1) existing debt service payments, (2) existing third-party contractual obligations, and (3) any funds on deposit in or to be deposited in the Agency's Low and Moderate Income Housing Trust Fund ("Housing Fund"). Notwithstanding the foregoing definition, for the purpose of making the remittance payments for the 2011-2112 Fiscal Year only, "Net Available Tax Increment" includes tax increment funds to be allocated for the 2011-2012 Fiscal Year to the Housing Fund pursuant to Sections 33334.2, 33334.4 and 33334.6 to the extent the Agency makes a finding that there are insufficient other moneys to meet its debt and other obligations, current priority program needs or its obligation to transfer funds to the Town under Section 34194.2 or pursuant to this Agreement.

B. The Agency shall transfer to the Town Net Available Tax Increment or other funds which will be used by the Town to make the remittance payments required by Part 1.9 and due in equal installments on January 15 and May 15 of each fiscal year. The amount transferred to the Town in each fiscal year shall not exceed the amount required for the Town to pay the remittance amount for that fiscal year determined by the State Director of Finance pursuant to Part 1.9. The transfers shall be made in two installments

each year to coincide with the January 15 and May 15 due dates for the installments of the remittance payments.

- C. The Town shall timely remit to the County Auditor the payments required by Part 1.9 as provided by the Ordinance. The Town's obligation to make such remittances shall be a special limited obligation of the Town payable solely from Net Available Tax Increment or any other available funds. Nothing contained in this Agreement shall be deemed to be a pledge of the Town's general fund revenues or other assets to make the remittance payments contemplated by Part 1.9. The Town may choose to fund the remittance payments solely from Agency funds and assets and is not obligated to use other funds to make those payments.
- D. The obligations of the Agency under this Agreement shall be payable in the first instance out of Net Available Tax Increment, as defined in the above recitals and/or as defined or provided in any applicable constitutional provision, statute or other provision of law now existing or adopted in the future, levied by or for the benefit of taxing agencies in the Agency's redevelopment project areas, and allocated to the Agency and/or any lawful successor entity of the Agency and/or any entity established by law to carry out the redevelopment plan for the redevelopment project areas and/or expend tax increment or pay indebtedness of the Agency to be repaid with tax increment, pursuant to Section 33670 or any applicable constitutional provision, statute or other provision of law now existing or adopted in the future. If Net Available Tax Increment in a given fiscal year is insufficient to pay the entire amount of the remittance payment, then the Agency may also transfer to the Town income received by the Agency from its projects and programs or any other additional funds available to it.

3. <u>LIABILITY AND INDEMNIFICATION.</u>

In contemplation of the provisions of California Government Code section 895.2 imposing certain tort liability jointly upon public entities solely by reason of such entities being parties to an agreement as defined by Government Code section 895, each of the Parties, as between themselves, pursuant to the authorization contained in Government Code sections 895.4 and 895.6, shall each assume the full liability imposed upon it, or any of its officers, agents or employees, by law for injury caused by negligent or wrongful acts or omissions occurring in the performance of this Agreement to the same extent that such liability would be imposed in the absence of Government Code section 895.2. To achieve the above-stated purpose, each Party indemnifies, defends and holds harmless the other Party for any liability, losses, costs or expenses that may be incurred by such other party solely by reason of Government Code section 895.2.

4. RESERVATION OF RIGHTS; EFFECTIVE DATE; TERMINATION FOR INVALIDITY OF AB 27.

By this Agreement the Town is not warranting or guaranteeing the payment of money to any other entity, and the Town reserves the right to cease making the payments required by AB 27 should the amount of such payments (as determined by the Department of Finance) prove to be in excess of the available funds not otherwise obligated for other uses or for any other reason. Moreover, this Agreement shall in no way be construed as requiring the Town to abide by AB 26 or AB 27 in the event either, or both, bills are found unconstitutional or otherwise legally invalid in whole or in part, nor shall this Agreement

have the effect or give rise to any waiver of rights or remedies that the Town or Agency may have, whether in law or in equity, to challenge AB 26 or AB 27. This Agreement shall not be construed as the Town's or Agency's willing acceptance of, or concurrence with, either AB 26 or AB 27, nor does this Agreement evidence any assertion or belief whatsoever on the part of the Town that said bills are constitutional or lawful.

While the Town intends to make the remittances as provided for in AB 27 and pursuant to this Agreement, the remittances shall be made under protest and without prejudice to the Town's right to recover such amounts and interest thereon, to the extent there is a final determination by a court of competent jurisdiction that AB 26 or AB 27, or both, are unconstitutional or otherwise unlawful. The Town and the Agency reserve the right, regardless of any remittance made pursuant to this Agreement, to challenge the legality of AB 26 or AB 27, or both.

The CRA Lawsuit and/or other actions challenging the validity of AB 26 and AB 27 has, or have been, or may be filed on behalf of cities, counties and redevelopment agencies. The California Supreme Court has issued a stay of the effectiveness of portions of AB 26 and AB 27 in the CRA Lawsuit. Until and unless the stay issued by the California Supreme Court has been lifted or dissolved, this Agreement shall not become effective, the Town shall not be obligated to make any community remittance for the duration of such stay and the Agency shall not be obligated to remit funds to the Town to enable the Town to make such payments. Moreover, to the extent that the California Supreme Court or any court of competent jurisdiction determines that the provisions of AB 27 regarding the making of remittances to the County Auditor are invalid for any reason, this Agreement shall be deemed null and void and of no further force and effect when all petitions for rehearing and appeals from such determination are exhausted or unsuccessful, or time for filing petitions for rehearing and appeals therefrom has lapsed.

5. <u>ENTIRE AGREEMENT; WAIVERS; AND AMENDMENTS.</u>

- A. This Agreement shall be executed in duplicate originals, each of which is deemed to be an original. This Agreement constitutes the entire understanding and agreement of the Parties with respect to the subject matter hereof.
- B. This Agreement integrates all of the terms and conditions mentioned herein or incidental hereto, and supersedes all negotiations or previous agreements between the parties with respect to the subject matter of this Agreement.
- C. This Agreement is intended solely for the benefit of the Town and the Agency. Notwithstanding any reference in this Agreement to persons or entities other than the Town and the Agency, there shall be no third party beneficiaries under this Agreement.
- D. Any waiver or amendment of the provisions of this Agreement must be in writing and signed by the authorized representative of the parties.

6. SEVERABILITY.

If any term, provision, covenant or condition of this Agreement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remainder of the provisions of this Agreement shall continue in full force and effect unless the rights and obligations of

the Parties have been materially altered or abridged by such invalidation, voiding or unenforceability.

7. BINDING ON SUCCESSORS.

This Agreement shall be binding on and shall inure to the benefit of all successors and assigns of the Parties, whether by agreement or operation of law. This Agreement shall survive any full or partial merger of the Town and the Agency and shall remain in full force and effect and be fully enforceable according to its terms.

A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE TOWN OF YUCCA VALLEY APPROVING A REMITTANCE AGREEMENT WITH THE TOWN OF YUCCA VALLEY IN ACCORDANCE WITH ASSEMBLY BILL AB X1 27

WHEREAS, the Redevelopment Agency of the Town of Yucca Valley (the "Agency") administers the implementation of various redevelopment projects, programs, and activities within the redevelopment project area in the Town of Yucca Valley (the "Town"); and

WHEREAS, on June 15, 2011, the State Legislature passed Assembly Bill X1 26 ("AB 26") and Assembly Bill X1 27 ("AB 27"), and on June 29, 2011, Governor Edmund G. Brown Jr. signed AB 26 and AB 27; and

WHEREAS, AB 26 generally prevents redevelopment agencies from entering into new or amended obligations or contracts, and eliminates redevelopment agencies and winds down their operations; and

WHEREAS, AB 27 allows redevelopment agencies to remain in existence, and to gain an exemption from the provisions of AB 26, in exchange for the payment of substantial sums of money on an annual basis to the San Bernardino County Auditor-Controller ("County Auditor"); and

WHEREAS, AB 27 codified Part 1.9 of Division 24 of the California Health and Safety Code ("Part 1.9"), which now comprises a portion of the California Community Redevelopment Law; and

WHEREAS, AB 27 establishes a "voluntary alternative redevelopment program" ("Alternative Program"), whereby the Agency is authorized to continue to exist upon the Town's enactment of an ordinance to comply with the provisions of Part 1.9; and

WHEREAS, AB 27 provides that, in order to enable the Agency to be included in the Alternative Program, the Town must notify the County Auditor, the State Controller, and the State Department of Finance, on or before November 1, 2011, that the Town will comply with the provisions of Part 1.9 by adoption of an ordinance consistent with Part 1.9; and

WHEREAS, the Town Council has adopted an ordinance to comply with Part 1.9 ("Ordinance") and notified the County Auditor, the State Controller and the State Department of Finance of its adoption; and

WHEREAS, AB 27 requires the Town to make specified remittances to the County Auditor in order to continue the existence of the Agency, as prescribed in Part 1.9 and the Ordinance; and

WHEREAS, Section 34194.2 of AB 27 authorizes the Agency to enter into an agreement with the Town, whereby the Agency will transfer a portion of its tax increment to the Town, in an amount not to exceed the amount of the Town's annual remittance to the County Auditor ("Remittance Agreement"), for the purpose of financing activities within the Town's redevelopment area that are related to accomplishing the Agency's project goals; and

WHEREAS, the purpose of the Remittance Agreement is to provide for the transfer of funds by the Agency to the Town in an amount not to exceed the amount of the remittance payments required by Part 1.9, utilizing net available tax increment and other funds in this current fiscal year and forthcoming fiscal years; and

WHEREAS, the validity of AB 26 and AB 27 is being challenged in a lawsuit entitled *California Redevelopment Association, et al.* v. *Matosantos, et al.*, California Supreme Court Case No. S194861 (the "CRA Lawsuit") and other lawsuits challenging the validity of AB 26 and AB 27 may be filed; and

WHEREAS, pending a decision on the merits in the CRA Lawsuit, the California Supreme Court has stayed the effectiveness of portions of AB 26 and AB 27, including, but not limited to, Sections 34194, 34194.1 and 34194.2; and

WHEREAS, it is the intention of the Agency for the Remittance Agreement to become effective only if and when the stay ordered by the California Supreme Court in the CRA Lawsuit has been lifted or dissolved; provided, however, if the decision on the merits in the CRA Lawsuit or any other lawsuit challenging the validity of AB 26 and/or 27 is that provisions of AB 27 authorizing the making of remittances to the County Auditor are invalid for any reason, this Agreement shall be null and void and of no effect; and

WHEREAS, the Agency Board has reviewed and duly considered the Staff Report, documents and other evidence presented at the meeting and believes that it will be in the best interest of the Agency and the health, safety, morals and welfare of the residents of the Town, and in accord with the public purpose and provisions of applicable state and local law and requirements, for the Agency to enter into a Remittance Agreement with the Town and for the Agency to participate in the Alternative Program.

NOW, THEREFORE, BE IT RESOLVED BY THE REDEVELOPMENT AGENCY OF THE TOWN OF YUCCA VALLEY AS FOLLOWS:

SECTION 1. The above recitals are true and correct and incorporated herein by this reference.

<u>SECTION 2.</u> The Agency Board hereby approves the Remittance Agreement attached hereto as Exhibit "A" and incorporated herein by this reference.

<u>SECTION 3.</u> The Chair, or designee, is authorized on the Agency's behalf, to execute the Remittance Agreement.

SECTION 4. The Executive Director, or designee, is authorized, on the Agency's behalf, to execute and deliver all other documents and take all actions necessary and appropriate to facilitate the Agency's continued participation in the Alternative Program, after the Town has enacted the Ordinance and while the Ordinance remains in effect.

RESOLUTION OF THE YUCCA VALLEY REDEVELOPMENT AGENCY REDUCING ITS ALLOCATION TO THE LOW AND MODERATE INCOME HOUSING FUND FOR THE 2011-12 FISCAL YEAR AND MAKING CERTAIN FINDINGS

WHEREAS, pursuant to Community Redevelopment Law (California Health &Safety Code §33000 et seq.) (the "CRL"), the Yucca Valley Redevelopment Agency (the "Agency") is required to annually deposit at least twenty percent (20%) of tax increment revenue allocated to the Agency into a separate fund (the "Low and Moderate Income Housing Fund") dedicated for the purpose of increasing, improving, and preserving the community's supply of low- and moderate-income housing; and

WHEREAS, Assembly Bill xl 27 ('ABxI 27") was passed by the California State Legislature, signed by the Governor, and has been codified as Part 1.9 of Division 24 of the California Health and Safety Code, commencing with Section 34192 ("Part 1.9"); and

WHEREAS, ABx1 27 establishes an "Alternative Voluntary Redevelopment Program" pursuant to which the Agency may continue to exist and carry out the provisions of the CRL if the Town of Yucca Valley (the "Town") enacts an ordinance to comply with the provisions of Part 1.9, including the remittance of certain payments to the County Auditor-Controller as described in California Health and Safety Code Section 34194 (the "Community Remittances");

WHEREAS, the Town Council of the Town (the "Town Council") has adopted an ordinance committing the Town to comply with Part 1.9, including making the Community Remittances; and

WHEREAS, pursuant to Health and Safety Code Section 34194.2, the Town and the Agency have entered into an agreement (the "Remittance Agreement") pursuant to which the Agency will annually transfer a portion of its tax increment to the Town, in an amount not to exceed the amount of the Community Remittance that the Town is required to remit to the County Auditor-Controller for the applicable year; and

WHEREAS, Health and Safety Code Section 34194.3 authorizes the Agency to reduce its deposit to the Low and Moderate Income Housing Fund for the 2011-12 fiscal year if the Town complies with the provisions of Part 1 .9 and the Agency finds that there are insufficient other moneys to meet the Agency's debt and other obligations, current priority program needs, or the Agency's obligations under the Remittance Agreement; and

WHEREAS, the Staff Report accompanying this Resolution (the "Staff Report") describes the Agency's financial obligations for Fiscal Year 2011-12, including the Agency's debt service obligations, contractual obligations, and program requirements.

NOW THEREFORE the Board of the Yucca Valley Redevelopment Agency hereby resolves:

- 1. Based upon the information set forth in the Staff Report and the evidence in the record, including the testimony, documents and other written evidence presented at the meeting at which this Resolution was considered, that the Agency lacks sufficient funds to meet the Agency's debt and other obligations, current priority program needs, and the Agency's obligations under the Remittance Agreement during Fiscal Year 2011-12. The finding that the Agency lacks sufficient funds to meet the Agency's debt and other obligations, current priority program needs, and the Agency's obligations under the Remittance Agreement are supported, without limitation, by the following facts and evidence:
 - The required AB 27 payment will result in an Agency funding shortfall of an estimated \$873,160 for the 2011/2012 fiscal year.
 - The Agency will receive an estimated amount of \$435,000 in funds allocable to the Low and Moderate Income Housing Fund. These funds are needed to off-set the above-noted shortfall.
- 2. Consistent with Health and Safety Code Section 34194.3, based upon the information set forth in the Staff Report and the evidence in the record, including the testimony, documents and other written evidence presented at the meeting at which this Resolution was considered, that it is necessary for the Agency to reduce its allocation to the Low and Moderate Income Housing Fund for Fiscal Year 2011-12 by the sum of Four Hundred Thirty Five Thousand Dollars (\$435,000).
- 3. The Agency's deposit of funds to the Low and Moderate Income Housing Fund for Fiscal Year 2011-12 shall be reduced by the sum of Four Hundred Thirty Five Thousand Dollars (\$435,000).
- 4. Authorizes the Agency Executive Director, or Treasurer, to take such actions as are necessary and appropriate to carry out and implement the intent of this Resolution.
