- d. “What to do to get enough sleep; the benefits of getting sleep” will be the last and final segment of the Sleep Deprivation video. Commissioners Green, Vice Chair Green, Moffitt, and Idnani will lead the production of this segment. Youth Commissioners will act out scenarios.


