**STAFF REPORTS**

1. Review of Town Regulations Regarding No Smoking Areas in Town Parks

Recreation Supervisor, Sue Earnest, explained that this item was returning for further discussion at the request of the Youth Commissioners in order to get additional input from members that were not present for the prior meeting on the subject.

The Commission reviewed the Town's regulations regarding no smoking areas at Town parks and the existing Facility Policy and Parks Ordinance and discussed possible revisions to these regulations. After discussion, the Commission determined that there was consensus on the following:

1. That the specific language found in the Facility Policy regarding smoking should be added to the Parks Ordinance in order to provide for enforcement of said rules and regulations. The Commission is in favor of revising the language of the Parks Ordinance to include the more specific language from the Facility Policy regarding smoking restrictions. They were also in favor of adding additional language requiring an escalating fine upon each violation beginning with \$100.00 and increasing thereafter.
2. In addition to adding the Facility Policy language to the Parks Ordinance, commission requested that a statement of purpose should be added in regards to why these smoking regulations are being put in place (health concerns, etc). The sample statements from other communities should be used as an example.
3. That a signage requirement be added that ensures that adequate no smoking signs are posted at each entryway to play and athletic areas of the parks. These signs should be the "universal" type that feature the red circle/slash symbol. There should be no smoking signage at the entrance to each facility area, such as playground or athletic field, that included the fine amount and ordinance number. The Commission discussed the placement of No Smoking signs at local parks including Essig Park, the Community Center, the soccer field, softball field, basketball courts, library, playground and snack bar.
4. The Commission is also in favor of placing a cigarette butt disposal receptacle next to each sign. They recommended the butt receptacles that concealed the butts so that children and others can not retrieve them.


## ANNOUNCEMENTS
