Background and Analysis:

The Youth Commission is appointed by the Town Council to provide a link between the youth of the community and their local government. To fulfill this role, each commissioner is encouraged to provide input to staff at Youth Commission meetings. Some issues are likely to generate commission discussion and a need for a formal commission recommendation. Those items will be placed on a future agenda to allow for staff preparation and public discussion of the issue.

In addition to those issues that will come up from time to time, the Youth Commissioners typically adopt goals that further their community involvement. Town staff assists the commission to establish and achieve their annual goals.
