## RESOLUTION NO. 07-03

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF YUCCA VALLEY, CALIFORNIA, CERTIFYING BALLOTING RESULTS AND CONFIRMING THE ASSESSMENTS APPROVED BY THE VOTING LANDOWNERS FOR LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT 1, ANNEXATION NO. 1, ZONE NO. 2 AND STREET AND DRAINAGE MAINTENANCE DISTRICT NO. 1, ANNEXATION NO. 1, ZONE 2 FOR TM 16587.

NOW, THEREFORE, BE IT RESOLVED that Town Council of the Town of Yucca Valley does resolve as follows:

Maintenance District No. 1, Annexation No. 1, Zone No. 2 are hereby confirmed and
may be levied upon real property within the Town of Yucca for fiscal year 2007-08 at the
rate not to exceed the maximum allowable assessment as approved by property owners
subject to the assessment.
