FOR
GRANT OF EASEMENT
DEDICATION OF PUBLIC RIGHT-OF-WAY OR PUBLIC EASEMENT
(UPDATED NOVEMBER 2021)**

The Town of Yucca Valley may require a property owner to dedicate a portion of their property(ies) as part of the Conditions of Approval required for development or improvement of the property. This dedication is in accordance with Town of Yucca Valley Municipal Code Chapter 9.30, in conjunction with the Town's General Plan to obtain the ultimate right-of-way necessary for the current roadway designation abutting said property(ies).

FROM APPLICANT

1. Submit the attached Grant of Easement Right-of-Way/Public Easement Dedication application with applicable information filled in.

After approval of legal description and plat:

2. Submit signed and notarized Grant of Easement for property adjoining dedication area.
3. Exhibit A and B signed and stamped by the engineer or surveyor.

NOTE: Registered engineers CANNOT prepare and seal a legal description unless they are licensed BEFORE January 1, 1982 (registration number must be lower than 33965).

EXHIBIT "A":

- a. Approved METES and BOUNDS legal descriptions of proposed public right-of-way or public easement, labeled as EXHIBIT "A".
- b. Closure reports for dedication configuration.

EXHIBIT "B":

- a. Plat labeled as EXHIBIT "B" 8-1/2" X 11" plat, prepared by a qualified professional (see NOTE above) that will show dedication described in Exhibit "A".
- b. Bearings and distances will be shown sufficient to clearly indicate the proposed dedication. Tables may be used if so desired.
- c. Existing edge of pavement or curb, gutter, sidewalk, and all existing structures within proposed right-of-way/easement with dimensions to nearest lot lines.
- d. North arrow, pointing up or to the right with scale of drawing. Scale must be sufficient to clearly show what is being contemplated. Use engineer's scale only.
- e. Show final square footage and acreage for area of dedication.

Additional street improvement or landscape plans may be required if requested by the Town Planning Division.

SUBSEQUENT SUBMITTALS: Corrections should be submitted via e-mail provided to the consultant by the Town of Yucca Valley Engineering Division.

FINAL SUBMITTAL: 1 set of original legal descriptions and exhibits signed and sealed by qualified professional and submitted to Town of Yucca Valley Engineering Division for final sign-off.

2. Engineering Division will forward the exhibits above mentioned and application to plan checker for review and comment.
3. Plan Checker will send back comments and redlines to the Engineering Division.
4. The Engineering Division will forward comments and redlines to the applicant/consultant via e-mail. Consultant will address comments and resubmit on the same email to ssraw@yucca-valley.org. **This process will repeat as needed until all plan checker comments are completely addressed.**
5. After the consultant has addressed all review comments, the plan checker approves the exhibits, the Engineering Division will inform the applicant/consultant of the approval.
6. The applicant/consultant will mail original signed and notarized Grant of Easement; and final Exhibits "A" and "B" documents signed and stamped by the engineer or land surveyor.
7. The Engineering Division will route the signed dedication package to the Town Clerk for signatures.
8. The Engineering Division will transmit final signature documents to San Bernardino County Recorder. The Town Engineering Division will email the consultant/owner recorded documents after they are recorded and retain original recorded documents in their archives.
