The Town of Yucca Valley is submitting the bi-monthly Western Joshua Tree permitting report for the period of March 2022 through April 2022.

The report for the designated period has 73 projects. \$181,700 were collected for mitigation fees for the Western Joshua Tree. Please find enclosed the reports reflecting the activity and fees collected.
