## Program details:


Started in 2019, YVML is a 501c3 organization focused on artist and musician residencies and art based workshops. Our mission is to provide equitable and accessible art education and to be a platform for cultural awareness. YVML is a place for art classes, 2 music events per year, and an artist/musician residency. Artist in residence would have access to the studio facility and temporary lodging (7 residencies per year at 2 weeks each).

- \* We currently have 1 full time and 2 part time staff. I would like this to increase to 2 full time and 1 part time staff
- \* We offer about 45 art workshops per year with 8 students each. (The most we would have on the property at one time for workshops would be 15). The workshops last anywhere from one day to five days. Materials taught include: glass fusing, concrete sand casting, basic metal joining, jewelry and felting. This is not a place for manufacture but a place to make art. With a new building, we would like to increase the number of workshops to 100 per year in order to increase staff.
- \* Our hours of operation are intermittent and we close June August and mid Dec mid Jan. The only full time staff member works approximately 9 5, part of which is remote. The workshops are anywhere from 1 5 days in length and the studio during those classes is only open from 9am 5pm.
- \* Activities include: art based workshops, 8 artist and musician residencies (per year), a small art gallery and 2 performance events (per year).
- 1. The residency program is 2 weeks in length and we provide lodging, supervised access to the studio, individualized instruction and technical assistance. We currently offer residencies to 7 visual artists per year and one musician per year. We may increase the number of musicians per year to 5 but keep the visual artists at 7 per year.
- 2. The performance events are typically held on a Friday or Saturday evening from approximately 7 9pm. Our average attendance is no more than 25. We intend to have 2 events per year (one in the Spring, one in the Fall). We do not intend for this to increase.
- 3. The gallery has about 4 shows per year, each of which last about a month. Viewings are by appointment only and most of the artists are from SoCal. We have one opening reception that is open to the public.

Planned improvements for APN 059708121 would be: a 1500 square foot pre-engineered metal facility to be the art studio and increased parking with ADA. The property already has a house that would be used as temporary lodging for the two week residencies, a research library accessible to the public by appointment and staff offices. We would like to include an ADA toilet in the new studio building to accommodate disabled artists.
